- Continues the investments into our nation's infrastructure
 - o \$2B for highway grants
 - o \$2B for Capital Investment Grants
 - o \$1B for the Department of Transportation's BUILD grant program
 - o \$916M for investments into our airports and transit systems
 - o \$230M for seaports, the third year in a row I have been able to secure this funding
- Provides housing opportunities to our most vulnerable populations
 - o \$25.77B in public housing vouchers
 - o \$3.475B for Community Development Block Grants
 - o \$3B for Homeless Assistance Grants
 - o \$1.35B for the HOME Investment Partnerships Program
 - o \$1.5B for housing for persons living with HIV/AIDS, the elderly, and persons with disabilities
